Eligible MHZEVs must meet all of the following criteria:

- ✓ Be a new Medium or Heavy-duty vehicle<sup>1</sup>
- ✓ Be a battery-electric vehicle (BEV), hydrogen fuel cell electric vehicle (FCEV), or plug-in hybrid electric vehicle (PHEV)
- Meet all Canada Motor Vehicle Safety Standards, where applicable, and be intended for use on public streets, roads, and highways or other paved surfaces
- ✓ Be available for order/purchase/lease in Canada
- ✓ For class 2B and 3, be a commercial vehicle or a medium-duty passenger vehicle (MDPV) with an MSRP equal to or under \$100,000.
  - To be considered a commercial vehicle, one of the following criteria must be satisfied:
    - have a seating capacity of 9 passengers or more;
    - have a cargo area (for example, a pick-up truck box or bed) of at least 183 cm (72 in. or 6ft) in interior length; or
    - be a truck with container attachment capabilities (e.g., chassis cab, half truck).
